A MESSAGE FROM OUR DIRECTOR

This past year has been a season of transition and new beginnings. HDC has a new Executive Director, new staff members, new processes, and new programs - yet the mission holds fast, and the team remains focused on providing and improving housing opportunities for low-to-moderate-income residents in Rock Hill.

"We found that it was impossible to fulfill our mission using the same techniques, tools, and talent we grew to rely on. COVID-19 altered the landscape of affordable housing. Higher building costs, skyrocketing rents, and a scarce buying market left countless community members at risk of living in overcrowded residences, unsafe housing, and experiencing homelessness. As an organization, we met these challenges with innovation, organization, and dedication. In 2021 we focused on individuals experiencing homelessness. Our Rapid Re-housing Program provided both rent subsidy and intensive case management for 8 previously homeless families. After recognizing a critical community need, we designated our property on Maple St, as a Permanent Supportive Housing unit. This is the first collaborative partnership of its kind in Rock Hill. We were also able to assist 582 individuals with rent, utility, and mortgage assistance, complete 9 rehabs, assist 5 first-time homebuyers with down payment and closing cost assistance, and add 12 new affordable rental units to our inventory. These accomplishments were made possible by the dedicated staff members, board of directors, and community partners."





PERMANENT SUPPORTIVE HOUSING











Permanent Supportive Housing Services include housing cost subsidies, healthcare access, job training & career readiness, financial education, transportation assistance, and access to childcare.

NEW PROGRAMS

Permanent Supportive Housing

In an effort to address homelessness, the Housing Development Corporation of Rock Hill has committed their property on Maple St. as "Permanent Supportive Housing" unit for a 2-year feasibility study.

The Permanent Supportive Housing program follows the Housing First Model.

The tenant holds a lease and is responsible for paying 30% of their monthly income towards rent.

Target Population: Individuals experiencing chronic homelessness (determined using HUD standards).

WHAT WE DO

Our Mission: The mission of the Housing Development Corporation of Rock Hill is to provide and improve housing opportunities for low-to-moderate-income residents.

Our Vision: Inform. Educate. Empower. By providing homeownership education and assistance; rehabilitation assistance to owner-occupied homes; increasing affordable housing options; and offering foreclosure prevention counseling.

Rapid Rehousing

Our case manager works with local shelters to identify homeless individuals who are ready to be housed and works with those individuals to: search for housing, review their lease, assist them in the move-in process, subsidize their rent for a set period of time (while they work to increase their income), and meet with them monthly to check on their progress towards housing independence.
